The owner of 47 Webster Avenue appeared and stated that the space was rented to two businesses, a glass window business and to another person for storage. Mr. Aurilio reported that there are 2 businesses at 45 Webster Avenue, a body shop and storage area.

Alderman Heuston's motion, that the Superintendent of Inspectional Services meet with the owner of 47 Webster Avenue and inspect the property to determine the number of businesses operating at that location and report the findings to the Licenses and Permits Committee, was approved.
